Eligibility

Open to all amateur athletes who possess a current INBF card (\$35) or who obtain one the day of the show. Athletes must be **7 years Drug Free** from the date of the event.

Testing

Each athlete will take a **polygraph test** to ensure they have not taken anything listed on the INBF Banned Substance list. The polygraph test fee is included in the \$70 entry fee.

Awards

Bodybuilding - 1st-5th place in each weight class and overall
Figure - 1st-5th place (if there is a split in classes, 1st-5th place each class & overall)
Best Gym Award (presented to the gym with the highest placing athletes)

CD's only – CD must be preset to a maximum of 90 seconds. Cassette tapes will not be accepted.
